The Prinsburg City Council held its regular meeting on November 15, 2022, at 1:00 pm in the city council room. Mayor Roger Ahrenholz called the meeting to order. **Art 1** Jessica Green went over the Bond information for our Broadband project with ARVIG. She explained the payment amount and due dates. The first interest payment is due August 1, 2023 and the first Principal payment is due February 1, 2024. Dan Negen made a motion to approve the Resolution 2022-10:
