- ART 7 Mitch Swart gave an update on last month's Jt Powers meeting. First Responders are preparing quick response bags for two churches, with Niel Brouwer now fully trained. The Relief Association is on PERA, and all fire department physicals are complete. Cal Ahrenholz has retired; Chief Ryan Marcus will retire at year-end. Fundraisers and grants are supporting the department's active role in community events. Plans include installing electronic door locks at the Fire Hall and repairing the roof foam.
