

The Prinsburg City Council held its regular meeting on May 14, 2024, at 1:00 pm in the city council room. Mayor Roger Ahrenholz called the meeting to order. Present were council members Dan Negen, Mitch Swart, and Greg Bonnema, as well as City employee Sarah Van Dyken and Nolan Slagter. Josh Johnson with Bollig and Michelle Haefner with Bethesda. Absent Dalen Folkerts

Art 1 Roger opened the public hearing at 1:00PM. Michelle Haefner spoke for a few minutes on the Bethesda project. Greg Bonnema asked about the potential risk to the City and Michelle stated there was not to be any. The expected completion date will be sometime in the Fall/Winter of 2025. The purpose of the public hearing is to approve the Resolution as follows:

Dan Negen made the motion to approve Resolution 2024-08. Greg Bonnema supported the motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 2 Greg Bonnema made a motion to approve work to be done at the Treatment plant with Natural Systems Utilities. NSU will complete the work for a fixed, lump sum fee of \$15,792.00 in accordance with the terms and conditions given in report. Dan Negen supported this motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 3 Josh Johnson with Bollig reported on the Lead Service Water lines. The Health Department wants all information gathered by August/September of this year. After that they will determine what needs to be done and who pays for the work.

Josh also reported that Pleasant Ave should be done today, and then topsoil and seeding will need to be done.

The Water Tower information is still being gathered and worked on.

Art 4 Mitch Swart made a motion to approve the Minutes of the April 9, 2024, regular Council Meeting. Dan Negen supported this motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 5 Greg Bonnema made a motion to approve payment of claims as present to the council in the amount of \$71,044.12. Dan Negen supported the motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 6 Financials were passed out for information to the council.

Art 7 Dan Negen made a motion to approve the Building/Land Use permit for Gregg Duininck. He will be removing his existing garage and adding

an attached 2 car garage. Mitch Swart supported this motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 8 Greg Bonnema made a motion to approve Angel Mendoza for 2024 seasonal work. His pay for the summer will be \$17.00/hour. Dan Negen supported this motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart and Greg Bonnema. Nays: None. The motion carried.

Art 9 Mitch Swart reintroduced the subject of a portable hockey rink. The council had some questions and asked that more information to be given at the next meeting.

Art 10 Roger Ahrenholz is concerned with Yard Clutter and yard and street parking. He will continue to do research with other towns and report on the next meeting.

Art 11 Dan Negen made a motion to adjourn the meeting. Greg Bonnema supported this motion. Ayes: Roger Ahrenholz, Dan Negen, Mitch Swart, and Greg Bonnema. Nays: None. The motion carried.
